Purple Heron, *Ardea purpurea*, is a species of heron found in wetland and river and lake ecosystems. It is a widespread summer visitor to much of the southern half of Europe. The species inhabits wetlands from sea level to 1,800 m, showing a preference for dense, flooded, freshwater reedbeds (*Phragmites spp.*) in temperate areas (occupying *Typha*, *Scirpus* and *Papyrus* swamps elsewhere). It also utilises lake shores, river margins, ditches, canals, brackish water lagoons, rice-fields and coastal mudflats (European Red List 2015).

*Ardea purpurea* has a breeding population size of 12600-15800 pairs and a breeding range size of 242000 square kilometres in the EU27. The breeding population trend in the EU27 is Decreasing in the short term and Uncertain in the long term.

The EU population status of *Ardea purpurea* was assessed as Secure, because the species does not meet any of the IUCN Red List criteria for threatened or Near Threatened, or the criteria for Depleted or Declining (the EU27 population or range has not declined by 20% or more since 1980).

**This factsheet was produced for *Ardea purpurea purpurea* [West Europe & West Mediterranean/West Africa] population. Also other subspecies/populations of the same species occur within the EU27. The assessment of status at the European level and the introductory text were done at the species level in line with the criteria for assessment of the EU population status.**

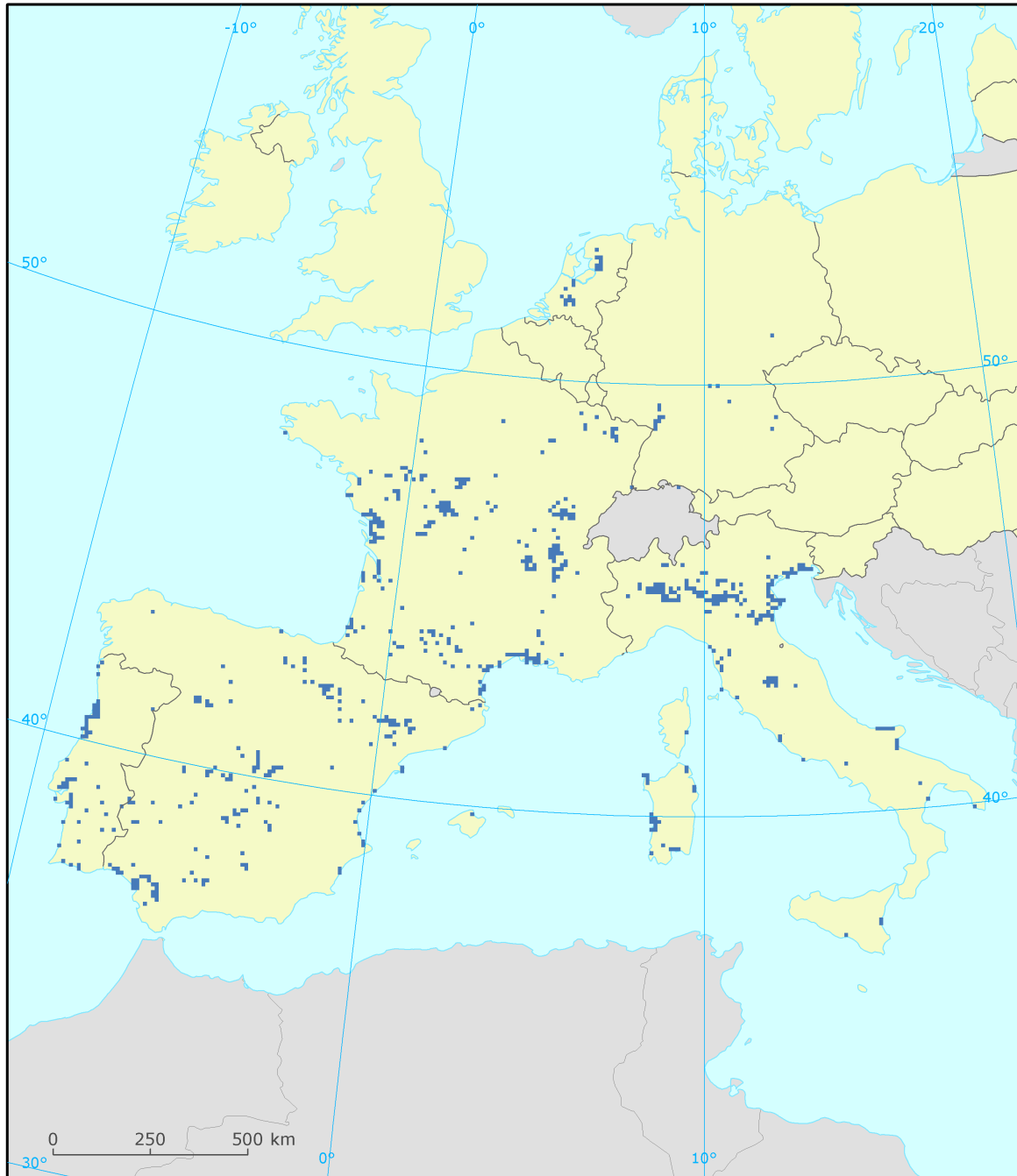

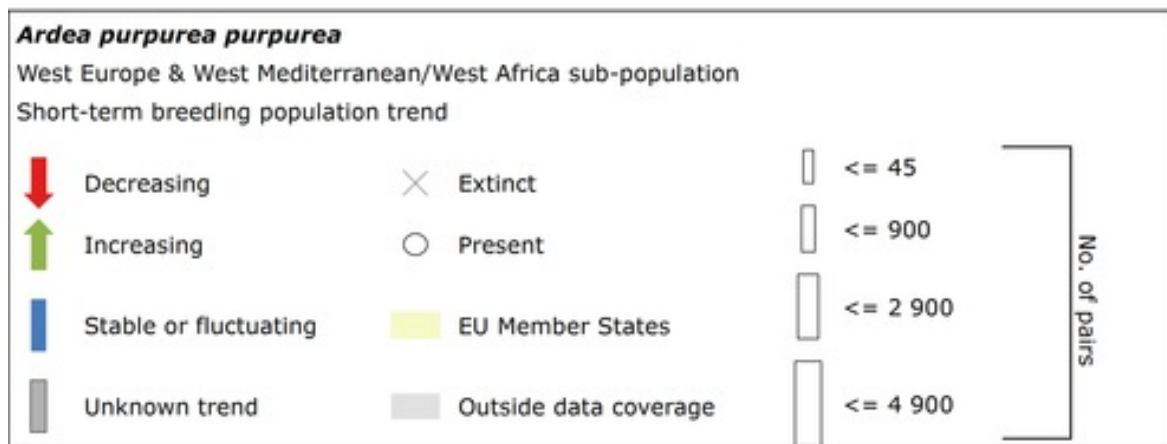

## Main pressures and threats reported by Member States

Pressures are activities which are currently having an impact on the species and threats are activities expected to have an impact in the near future. Pressures and threats were ranked in three classes 'high, medium and low importance', the table below only shows pressures and threats classed as 'high', for some species there were less than ten pressures and threats reported as highly important.

## Proportion of population covered by the Natura 2000 network

For the bird species triggering SPA classification Member States were asked to report the size of a species population occurring within the Natura 2000 network. The percentage of species population covered by the network was estimated by comparing the population size within the network and the total population size.

Member States were further requested to highlight up to five most important ('highly important') measures; the table below only shows measures classed as 'high', for many species there were less than ten measures reported as highly important.

<sup>i</sup> **Assessment of status at the European level:** The EU assessments of birds population status was made by the European Red List of Birds Consortium (under contract with the European Commission)

The EU27 population trends were assessed using these categories: '+' Increasing, '0' Stable, 'F' Fluctuating, '-' Decreasing, 'xu' Uncertain and 'x' Unknown. The breeding population size is estimated in majority of the cases as 'p' number of pairs. Alternative population units used are: 'males' number of males, 'i' number of individuals, 'cmales' number of calling males and 'bfem' number of breeding females. The winter population size is estimated as number of individuals.

<sup>ii</sup> **Species trends at the Member State level:** The percentage of the EU27 species population occurring in the Member States (% in EU27) is calculated based on the population size reported by the Member States.

<sup>iii</sup> **Percentage of coverage by Natura 2000 sites:** In some cases the population size within the Natura 2000 network has been estimated using a different methodology to the estimate of overall population size and this can lead to percentage covers greater than 100%. In such case the value has been given as 100% and highlighted with an asterisk (\*). The value 'x' indicates that the Member State has not reported the species population and/or the coverage by Natura 2000. No information is available for Greece and for non-Annex I species in the Czech Republic.
