Rustic Bunting, *Emberiza rustica*, is a species of passerine bird in the bunting family found in wetland and woodland and forest ecosystems.

Emberiza rustica has a breeding population size of 181000-331000 pairs and a breeding range size of 350000 square kilometres in the EU27. The breeding population trend in the EU27 is Decreasing in the short term and Decreasing in the long term.

The EU population status of *Emberiza rustica* was assessed as Threatened, as the species meets one or more of the IUCN Red List criteria for threatened at the EU27 scale.





The breeding population size is estimated in majority of the cases as 'p' number of pairs. Alternative population units used are: 'males' number of males, 'i' number of individuals, 'cmales' number of calling males and 'bfem' number of breeding females. The winter population size is estimated as number of individuals.

<sup>ii</sup>Species trends at the Member State level: The percentage of the EU27 species population occurring in the Member States (% in EU27) is calculated based on the population size reported by the Member States.
