

Having regard to specific contract **11.0661/SRFA/2014/692815/C2** concluded between the Commission and the Contractor on 27 November 2014 ("the Contract")

Whereas the Contractor has requested the Commission by letter of 01st September 2015 to extend the above contract,

Have agreed as follows :

Article 1

Article I.2.2 is replaced by the following article:

"I.2.2 The duration of the execution of the tasks shall end on **15th December 2015**. This period and all other periods specified in the Contract are calculated in calendar days. Execution of the tasks shall start from the date of entry into force of this specific contract. The period of execution of the tasks may be extended only with the express written agreement of the parties before such period elapses."

Article 2

All the other provisions of the Contract shall remain unchanged and shall continue to apply.

Article 3

The present amendment shall form an integral part of the Contract and it shall enter into force after signature by the contracting parties on the date indicated therein.
