



The *Eriogaster catax* is a moth species which is widely spread in Europe.

In all geographical regions (Alpine, Atlantic, Continental, Mediterranean and Pannonian) this species occurs its status is largely 'unknown' or 'inadequate'. There is a huge lack of data which makes a proper assessment of this species' status impossible. Only in Hungary its status is expected to be 'favourable'. According to the IUCN Red List data are deficient and an update is needed. Its last reported conservation status dates from 1994 and was 'Endangered'.
