



62B0 *Serpentinophilous grasslands of Cyprus*

Serpentinophilous grasslands of Cyprus are perennial herb communities growing on ultramafic rock substrates (dark coloured with high magnesium and iron content) such as serpentine, dunite, werhlite & hurzburgite. They are restricted to the Troodos Mts. (700-, but mainly 1700- 1950 m) and the Akamas peninsula (350 –450m). The vegetation consists of small patches of sparse plant cover on rocky outcrops and stony places with a specialised flora, including several endemic species.


The conservation status in the only reported Mediterranean region is still favourable and stable, in all parameters assessed by the only reporting country Cyprus. The area of the habitat remained unchanged, while a wider range was assessed.

The pressures and threats (of low intensity) are creation of paths and (cycling) tracks, trampling and overuse (including intensive goat grazing) or natural factors like fires and extreme temperatures.

Knowing that not all changes in conservation status between the reporting periods were genuine, Member States were asked to give the reasons for changes in conservation status. Bulgaria and Romania only joined the EU in 2007 and Greece did not report for 2007-12 so no reason is given for change for these countries. Greek data shown above is from 2001-06.

Main pressures and threats reported by Member States

Member States were asked to report the 20 most important threats and pressures using an agreed hierarchical list which can be found on the [Article 17 Reference Portal](#). Pressures are activities which are currently having an impact on the habitats and threats are activities expected to have an impact in the near future. Pressures and threats were ranked in three classes 'high, medium and low importance'; the tables below only show threats and pressures classed as 'high', for some habitats there were less than ten threats or pressures reported as highly important.

Member States were asked to report up to 20 conservation measures being implemented for this habitat using an agreed list which can be found on the Article 17 Reference Portal. Member States were further requested to highlight up to five most important ('highly important') measures; the table below only shows measures classed as 'high', for many habitats there were less than ten measures reported as highly important.

i Assessment of conservation status at the European biogeographical level: Current Conservation Status (Current CS) shows the status for the reporting period 2007-2012, Previous Conservation Status (Previous CS) for the reporting period 2000-2006. Reason for change in conservation status between the reporting periods indicates whether the changes in the status were genuine or not genuine. Previous Conservation Status was not assessed for Steppic, Black Sea and Marine Black Sea regions. For these regions the Previous status is therefore considered as 'unknown'. The percentage of the habitat area occurring within the biogeographical/marine region (% in region) is calculated based on the area of GIS distribution.

ii Percentage of coverage by Natura 2000 sites in biogeographical/marine region: In some cases the population size within the Natura 2000 network has been estimated using a different methodology to the estimate of overall population size and this can lead to percentage covers greater than 100%. In such case the value has been given as 100% and highlighted with an asterisk (*). The value 'x' indicates that the Member State has not reported the habitat area and/or the coverage by Natura 2000. No information is available for Greece. The values are only provided for regions, in which the occurrence of the habitat has been reported by the Member States.
