### *Salmo macrostigma*

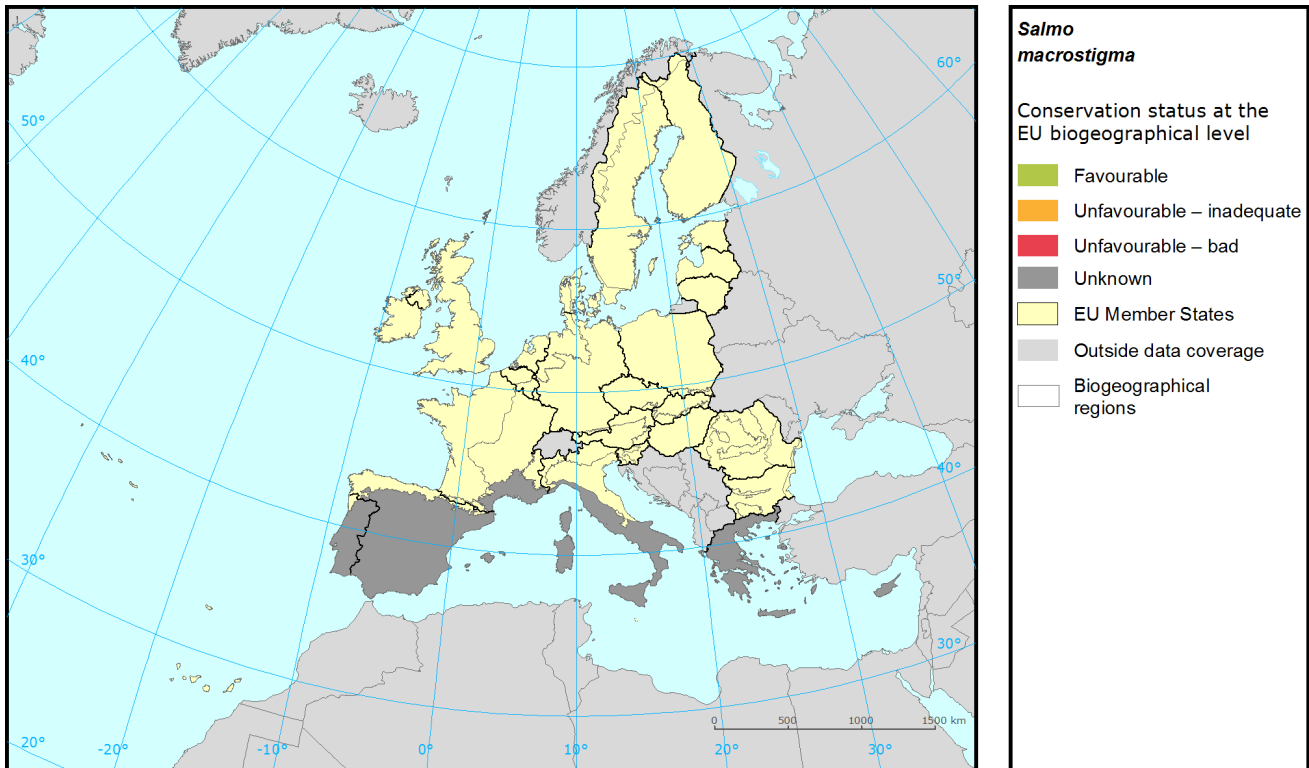
*Salmo macrostigma* is a species of freshwater trout that is restricted to Algeria in North Africa. According to the IUCN Red List many supposed observations of this species around the Mediterranean region are wrong, however, there is also no reliable distribution, abundance, trend and threat data at this time.

The species was reported by Italy, Greece and France for the Mediterranean biogeographical region during the previous reporting period, but for the current reporting period no reports were received. As a result the conservation status of the species has been assessed as 'unknown' and no pressures and threats were reported.

The IUCN Red List classifies the species as data deficient (<http://www.iucnredlist.org/details/61253/0> consulted on 4 March 2015).

Knowing that not all changes in conservation status between the reporting periods were genuine, Member States were asked to give the reasons for changes in conservation status. ## Main pressures and threats reported by Member States

Pressures are activities which are currently having an impact on the species and threats are activities expected to have an impact in the near future. Pressures and threats were ranked in three classes 'high, medium and low importance'; the tables below only show threats and pressures classed as 'high', for some species there were less than ten threats or pressures reported as highly important.

**i Assessment of conservation status at the European biogeographical level:** Current Conservation Status (Current CS) shows the status for the reporting period 2007-2012, Previous Conservation Status (Previous CS) for the reporting period 2000-2006. Reason for change in conservation status between the reporting periods indicates whether the changes in the status were genuine or not genuine. Previous Conservation Status was not assessed for Steppic, Black Sea and Marine Black Sea regions. For these regions the Previous status is therefore considered as 'unknown'. The percentage of the species population occurring within the biogeographical/marine region (% in region) is calculated based on the area of GIS distribution.

**ii Percentage of coverage by Natura 2000 sites in biogeographical/marine region:** In some cases the population size within the Natura 2000 network has been estimated using a different methodology to the estimate of overall population size and this can lead to percentage covers greater than 100%. In such case the value has been given as 100% and highlighted with an asterisk (\*). The value 'x' indicates that the Member State has not reported the species population and/or the coverage by Natura 2000. No information is available for Greece. The values are only provided for regions, in which the occurrence of the species has been reported by the Member States.
