The plant *Diplotaxis siettiana* is endemic to south-east Spain, it is limited to only one population in the island of Alborán (Almeria). It extincted after 1974 and it has been reintroduced into the island in 1999 - 48 plants were re-introduced but it is not sure that the population is self-sustaining. The species is a wild relative of brassica crops as well as being related to cultivated perennial wall rocket, *D. tenuifolia*. This species grows on fixed maritime sands covering volcanic table in altitude of 10-15 m, it constitute practically mono-specific communities. The IUCN Red List and red list of Spain classify the species as Critically Endangered (CR).

The conservation status is "Unknown" due to unknown population and future prospect. Trend unknown. The rarity, small reintroduced population allow to suppose that the conservations status will be likely "Unfavourable Bad". The previous conservation status was considered "Unknown".

The species is threatened mostly by competition, alteration of the habitat, nitrification, low number of individuals. Flowers and fruits as object of insect predation. Spraying by the sea water can cause species extinction. The military use, trampling, grazing by animals (rabbits, pigs) resulted in restriction of suitable habitats.

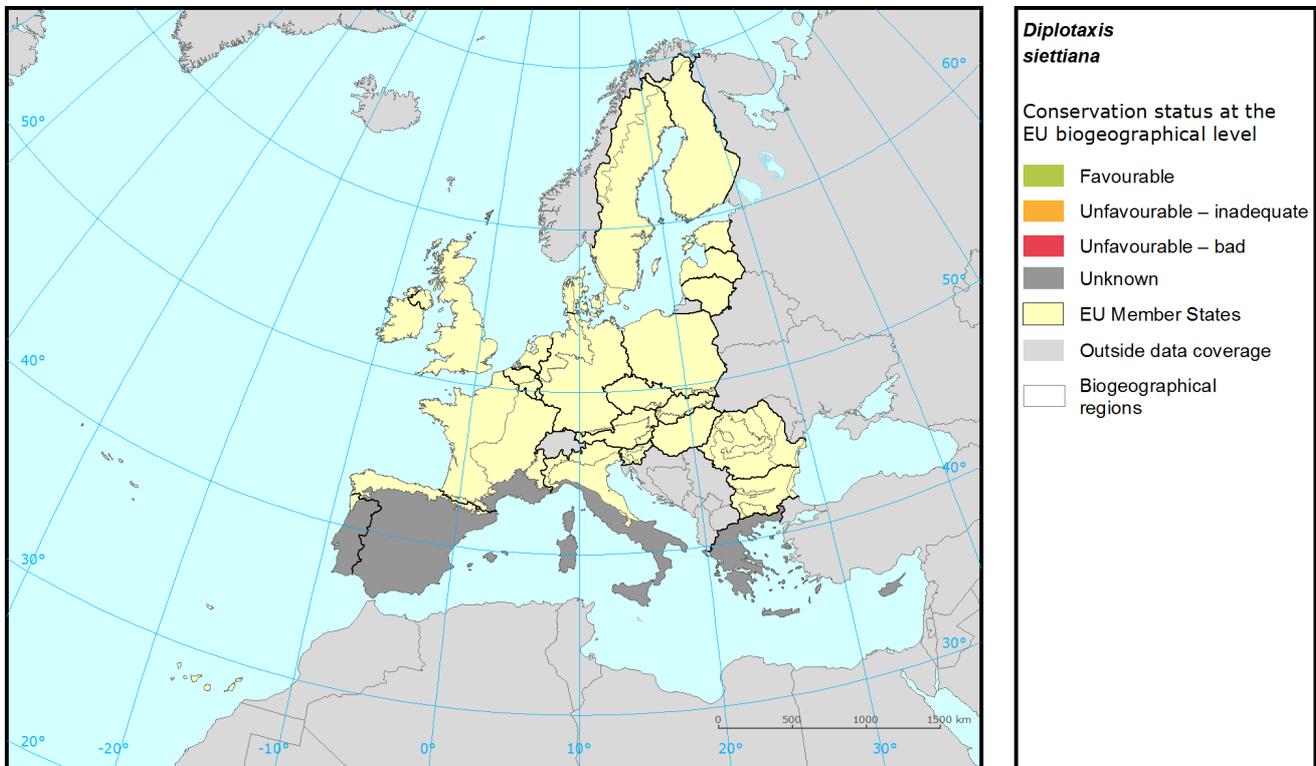
No changes in overall conservation status between 2001-06 and 2007-12 reports.

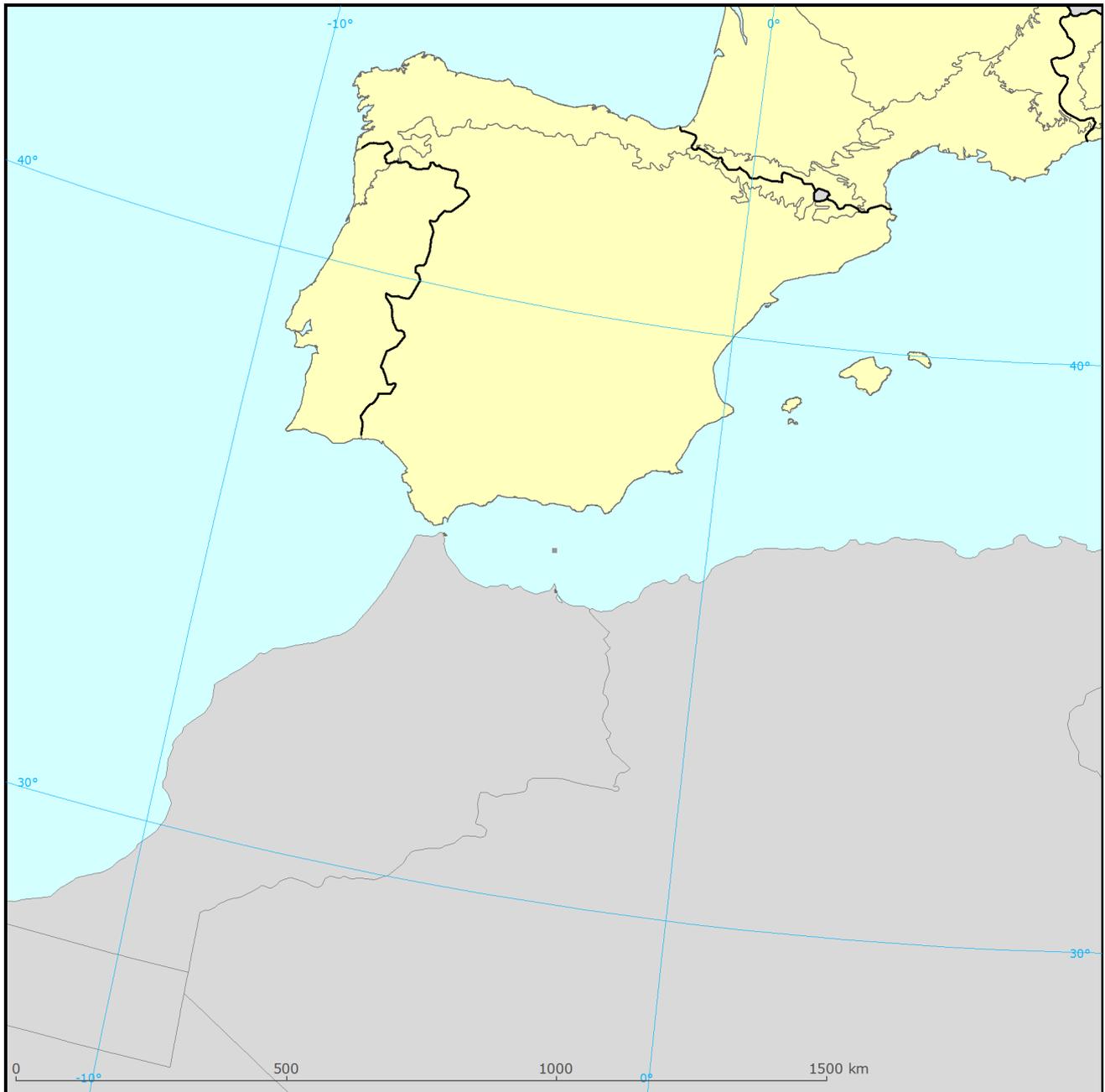

Knowing that not all changes in conservation status between the reporting periods were genuine, Member States were asked to give the reasons for changes in conservation status. Bulgaria and Romania only joined the EU in 2007 and Greece did not report for 2007-12 so no reason is given for change for these countries. Greek data shown above is from 2001-06.

Main pressures and threats reported by Member States

Member States were asked to report the 20 most important threats and pressures using an agreed hierarchical list which can be found on the [Article 17 Reference Portal](#). Pressures are activities which are currently having an impact on the species and threats are activities expected to have an impact in the near future. Pressures and threats were ranked in three classes 'high, medium and low importance'; the tables below only show threats and pressures classed as 'high', for some species there were less than ten threats or pressures reported as highly important.

i Assessment of conservation status at the European biogeographical level: Current Conservation Status (Current CS) shows the status for the reporting period 2007-2012, Previous Conservation Status (Previous CS) for the reporting period 2000-2006. Reason for change in conservation status between the reporting periods indicates whether the changes in the status were genuine or not genuine. Previous Conservation Status was not assessed for Steppic, Black Sea and Marine Black Sea regions. For these regions the Previous status is therefore considered as 'unknown'. The percentage of the species population occurring within the biogeographical/marine region (% in region) is calculated based on the area of GIS distribution.

ii Percentage of coverage by Natura 2000 sites in biogeographical/marine region: In some cases the population size within the Natura 2000 network has been estimated using a different methodology to the estimate of overall population size and this can lead to percentage covers greater than 100%. In such case the value has been given as 100% and highlighted with an asterisk (*). The value 'x' indicates that the Member State has not reported the species population and/or the coverage by Natura 2000. No information is available for Greece. The values are only provided for regions, in which the occurrence of the species has been reported by the Member States.
