Festuca duriotagana is a species of grass endemic to Iberian Peninsula. It was reported only from Portugal, where it occurs along the rivers Douro, Alto Tejo and Guadiana. The IUCN Red List mentions its occurrence in Spain. The occurrence in Spain is further suspected by the author of the Article 17 reports of Portugal. The species occurs in grasslands on rocky banks of rivers. The taxonomic status of this species is unclear. Originally the species was described based morphological characters. Due to morphological plasticity of this species group and lack of other evidence its populations were considered by some taxonomists as belonging to another species, *Festuca ampla*. The major part of the population occurs in the Mediterranean region and one locality is known also from the Atlantic region. It is listed as Data Deficient (DD) in the IUCN European Red List.

The conservation status is "Unknown" in both regions and information on actual trends or on status of either population or habitat of the species is not available. According to the information provided on <http://www.icnf.pt/portal/naturaclas/rn2000/p-set/psrn-flora> the status is most likely "Unfavourable" as species has undergone severe decline in past.

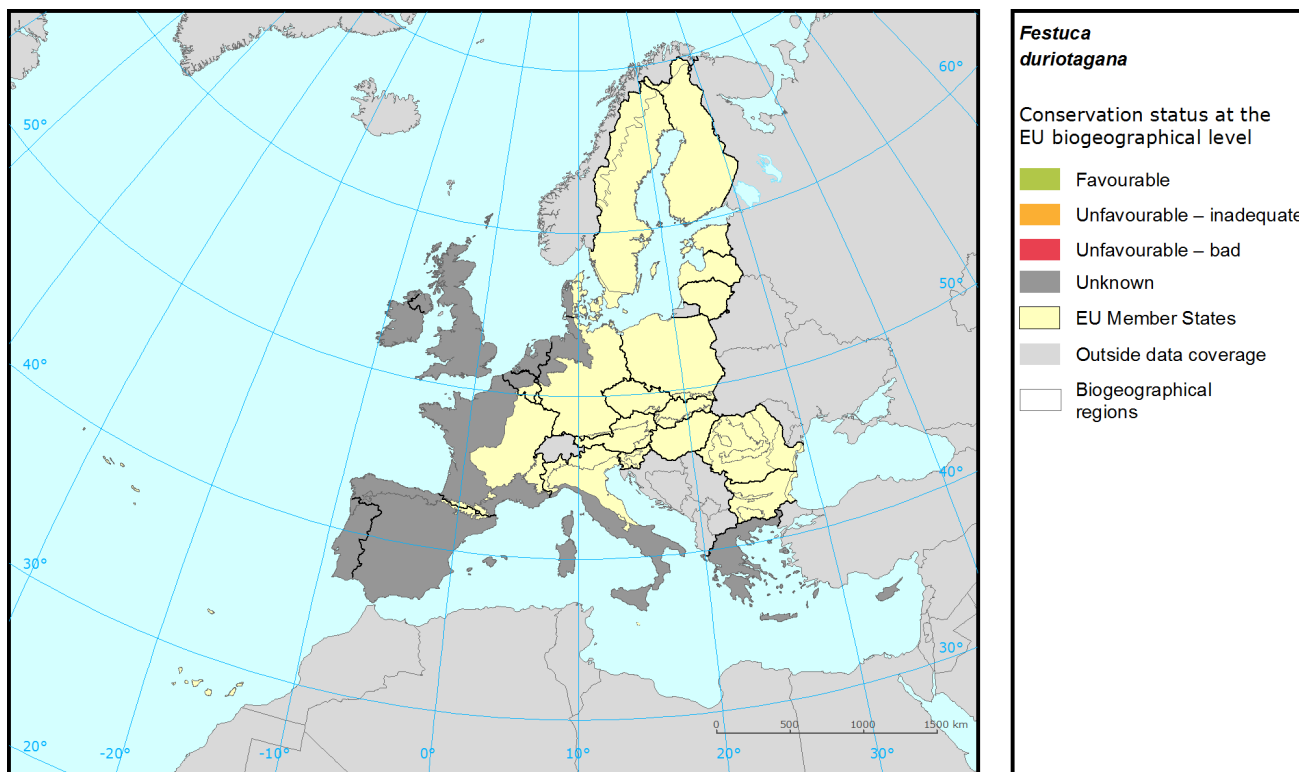
Main reported threats are modification of water courses and reservoirs.

No changes in overall conservation status between 2001-06 and 2007-12 reports in Mediterranean region. The species was not reported from Atlantic region 2001-06.

Better data required from Portugal.

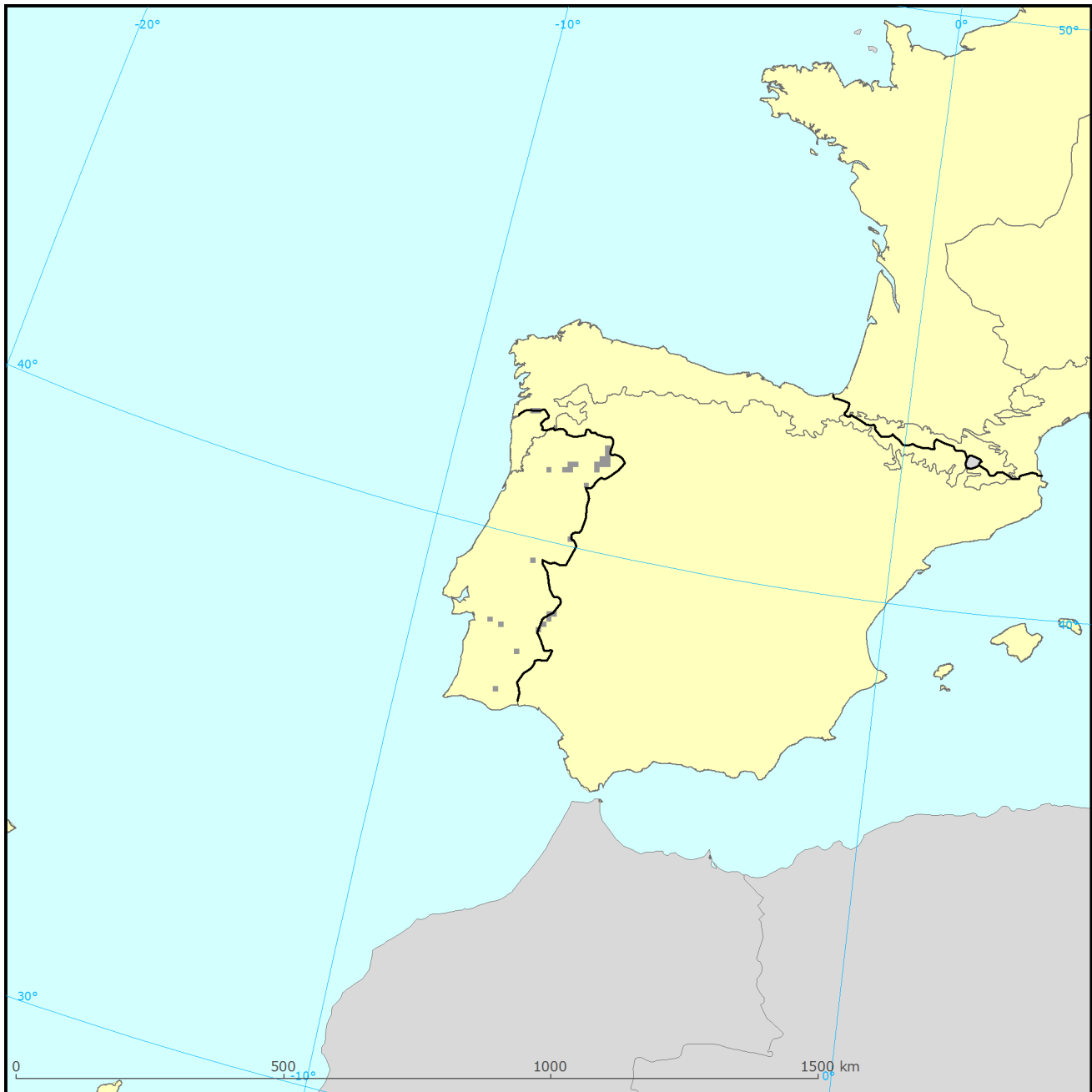

Knowing that not all changes in conservation status between the reporting periods were genuine, Member States were asked to give the reasons for changes in conservation status. Bulgaria and Romania only joined the EU in 2007 and Greece did not report for 2007-12 so no reason is given for change for these countries. Greek data shown above is from 2001-06.

Main pressures and threats reported by Member States

Member States were asked to report the 20 most important threats and pressures using an agreed hierarchical list which can be found on the [Article 17 Reference Portal](#). Pressures are activities which are currently having an impact on the species and threats are activities expected to have an impact in the near future. Pressures and threats were ranked in three classes 'high, medium and low importance'; the tables below only show threats and pressures classed as 'high', for some species there were less than ten threats or pressures reported as highly important.

i Assessment of conservation status at the European biogeographical level: Current Conservation Status (Current CS) shows the status for the reporting period 2007-2012, Previous Conservation Status (Previous CS) for the reporting period 2000-2006. Reason for change in conservation status between the reporting periods indicates whether the changes in the status were genuine or not genuine. Previous Conservation Status was not assessed for Steppic, Black Sea and Marine Black Sea regions. For these regions the Previous status is therefore considered as 'unknown'. The percentage of the species population occurring within the biogeographical/marine region (% in region) is calculated based on the area of GIS distribution.

ii Percentage of coverage by Natura 2000 sites in biogeographical/marine region: In some cases the population size within the Natura 2000 network has been estimated using a different methodology to the estimate of overall population size and this can lead to percentage covers greater than 100%. In such case the value has been given as 100% and highlighted with an asterisk (*). The value 'x' indicates that the Member State has not reported the species population and/or the coverage by Natura 2000. No information is available for Greece. The values are only provided for regions, in which the occurrence of the species has been reported by the Member States.
