The plant *Ulex densus* is endemic to Portugal in the Mediterranean region. It grows in the central-west coast of Portugal. This species is characteristic for the associations *Serratula estremadurensis* - *Thymenion sylvestris* and *Salvia sclareoidis* - *Ulicetum densi*. It can be found in the habitats: (5210) Arborescent matorral with *Juniperus* spp., (5330) Thermo-Mediterranean and pre-desert scrub, (9340) *Quercus ilex* and *Quercus rotundifolia* forests. The IUCN European Red List classifies the species as Least Concern (LC).

The conservation status is "Unfavourable Inadequate", the previous conservation status was "Unknown". The future prospect is "Unfavourable Inadequate" and the trend is unknown.

The species is threatened mostly by roads, motorways, urbanisation, industrial or commercial areas, communication networks, sand and gravel quarries. Trampling, overuse and natural fires are also regarded as threats.

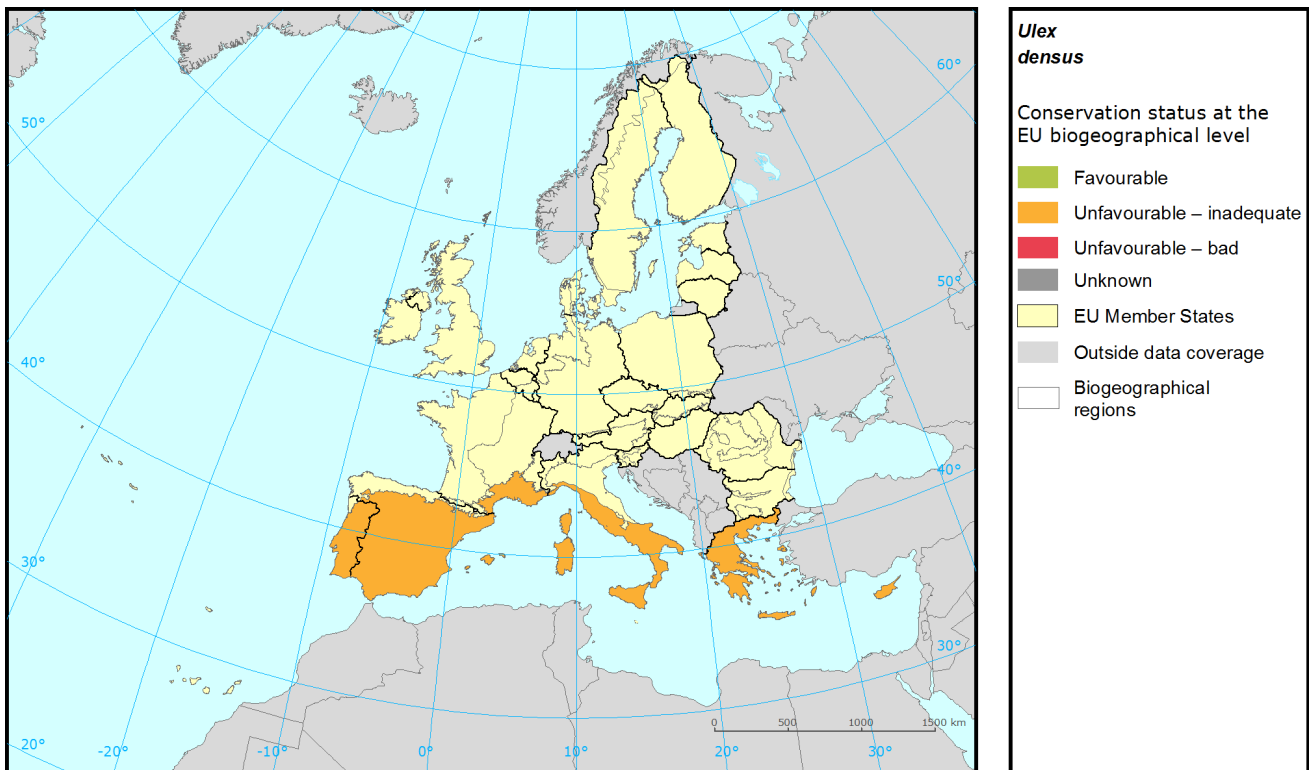
Changes in overall conservation status between 2001-06 and 2007-12 report are mostly caused by different methodical approach and better data rather than real change in conservation status.

Better data required from Portugal.

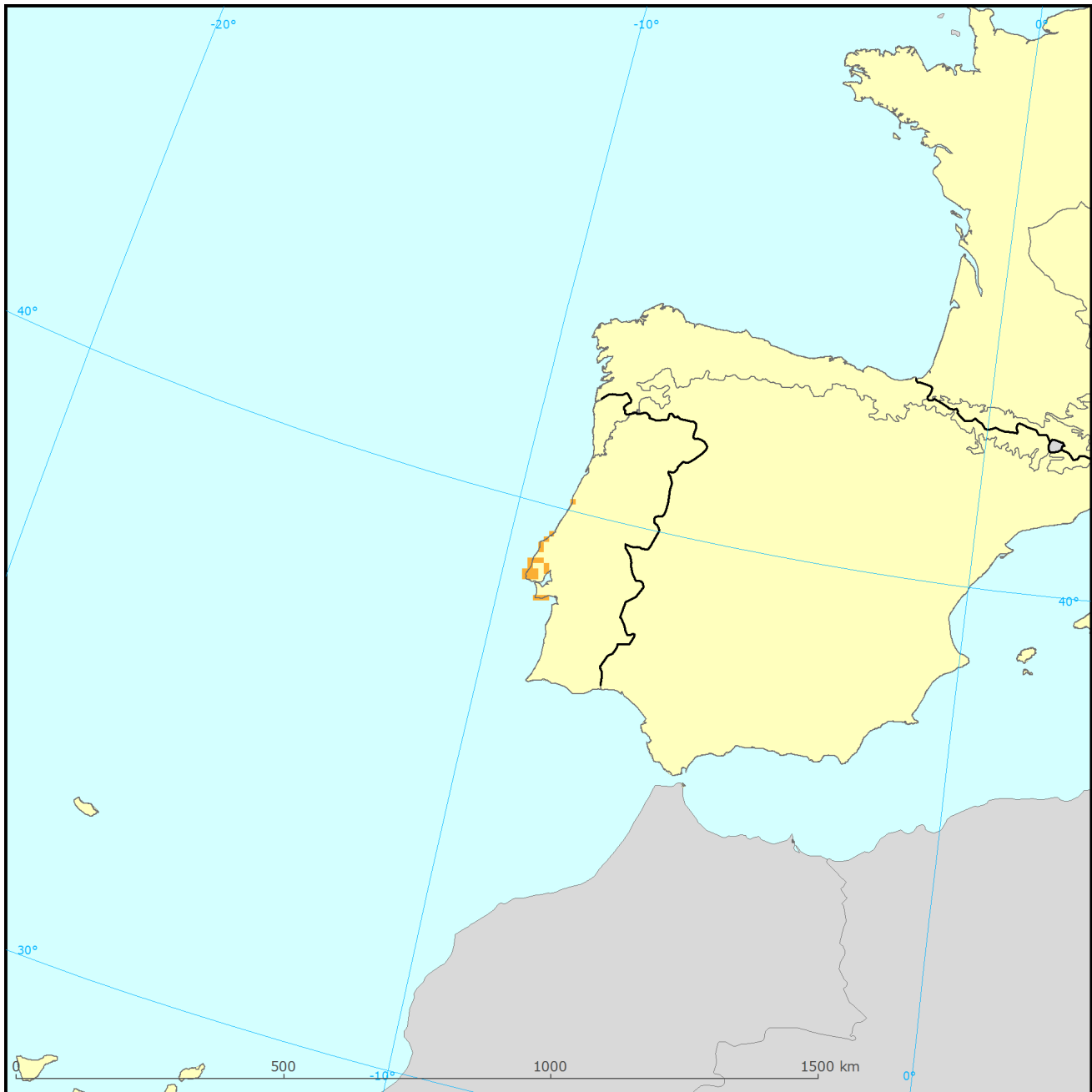

Knowing that not all changes in conservation status between the reporting periods were genuine, Member States were asked to give the reasons for changes in conservation status. Bulgaria and Romania only joined the EU in 2007 and Greece did not report for 2007-12 so no reason is given for change for these countries. Greek data shown above is from 2001-06.

Main pressures and threats reported by Member States

Member States were asked to report the 20 most important threats and pressures using an agreed hierarchical list which can be found on the [Article 17 Reference Portal](#). Pressures are activities which are currently having an impact on the species and threats are activities expected to have an impact in the near future. Pressures and threats were ranked in three classes 'high, medium and low importance'; the tables below only show threats and pressures classed as 'high', for some species there were less than ten threats or pressures reported as highly important.

i Assessment of conservation status at the European biogeographical level: Current Conservation Status (Current CS) shows the status for the reporting period 2007-2012, Previous Conservation Status (Previous CS) for the reporting period 2000-2006. Reason for change in conservation status between the reporting periods indicates whether the changes in the status were genuine or not genuine. Previous Conservation Status was not assessed for Steppic, Black Sea and Marine Black Sea regions. For these regions the Previous status is therefore considered as 'unknown'. The percentage of the species population occurring within the biogeographical/marine region (% in region) is calculated based on the area of GIS distribution.
